 - a. Cut-5 Operation: Exercise of 2 Year Extension expiring April 30, 2026.

Motion was made by Brian to approve the Renewal Agreements. Nicole seconded the motion.

Vote: 3 out of 5, board members in favor, Mark, Jon and Nicole

2 out of 5 opposed, Brian and Jason

*Jason Feldman shared he would vote in favor of the motion if the Agreement provided for a quarterly review of the financial statements rather than twice a year and the terms reflect a 45 day notice of termination which is in the existing Agreement.

- d. Consideration to Vote to Approve a New Traffic Violation Rule.
 - a. Issues of traffic violations in Boca Bridges are principally related to speeding and running stop signs.
 - b. An HOA treats a traffic violation as any other Covenant violation which means the offender is not being accused of violating state or city laws but of violating the Governing Documents of the Association.
 - c. The Association is still studying speed camera options.
 - d. To begin the process of enforcement the Board is voting to approve adoption of this new traffic violation rule which will permit fines to be imposed for violations.
 - e. The Board will also be approving the purchase of speed signs of Sauvignon Pkwy. The designated speed limit by the county is 30 MPH.

Motion was made by Brian to approve new a New Traffic Violation Rule.

Mark seconded the motion.

Vote: Unanimous - All In Favor.
